Adjudicatory Hearing	A hearing that is held within ninety (90) calendar days after the filing of the petition to determine whether there is legally sufficient evidence to find that the child is a delinquent child, a child in need of supervision, a neglected child or an abused child.
Administration for Children and Families (ACF)	A division of the Department of Health & Human Services. ACF promotes the economic and social well-being of families, children, individuals and communities with partnerships, funding, guidance, training and technical assistance.
Administrative Fair Hearing (AFH)	Process of the right to due process to appeal or disagree with a DFCS decision and/or action.
Administrative Office of Courts (AOC)	The Mississippi Administrative Office of Courts was established in July 1, 1993 in order to assist in the efficient administration of the nonjudicial business of the State's court system.
Adoption Agreement	This agreement is being made and entered into between the Mississippi Department of Human Services, (hereinafter "MDHS/DFCS")
Adoption and Foster Care Analysis Reporting System (AFCARS)	The Adoption and Foster Care Analysis and Reporting System (AFCARS) collects case-level information from state and tribal title IV-E agencies on all children in foster care and those who have been adopted with title IV-E agency involvement.
Adoption and Safe Families Act (ASFA)	The Adoption and Safe Families Act of 1997 [Pub. L. 105-89; 111 Stat. 2115; 42 U.S.C. § 1305 et seq.] is federal legislation which places responsibility with MDHS to establish policy and procedures designed to appropriately place children in permanent homes. This includes placing children in suitable adoptive homes approved by a licensed adoption agency or licensed social worker, in cases where restoration to the biological family is not safe, possible or appropriate.

Adoption Assistance/Subsidy (AA)	Financial assistance provided to the adoptive parents to assist in meeting the adopted child's special needs.
Adoption Placement (AP)	The time at which children begin living with their prospective adoptive parents, which often occurs before the legal finalization of the adoption.
Adoption Placement Agreement	An agreement between the pre-adoptive parent (s) and the Division of Family and Children's Services to place a child for adoption.
Adoption Specialist (AS)	Is the assigned social worker who is responsible for consulting with private and public professionals, identifying, and ensuring the provisions of targeted services necessary for the child to be adopted.
Adoption Subsidy Agreement	An agreement between the pre-adoptive parent (s) and the Division of Family and Children's Services to place a child for adoption.
Adoption Unit (AU)	that unit designed by the agency to have responsibility for adoptive placements made by and through DFCS to foster permanent connections for children whose permanent plan is adoption.
Adoption Worker (AW)	A worker is responsible for facilitating the adoption process for both the family that is adopting and the child who is being adopted.
Adoptive Home	A Resource Home that is licensed/approved by DFCS and meets licensure requirements for placement of a child. An Adoptive Home is intended to be permanent. The permanent relationship of the family and the child is formalized by the finalization of a legal adoption, with the consent of DFCS. DFCS Policy-Section D pg. 50 (Revised 9/3/15)
Adoptive Packet	All information pertaining to an adoption that is needed for the adoption to be finalized.
Adult Protective Services (APS)	Refers to remedial social, legal, health, mental health, and referral services provided for prevention, correction, or discontinuation of abuse or neglect which are necessary and appropriate under the circumstances to protect an abused or neglected vulnerable adult.
Advance Planning Document Update (APDU)	A document or record submitted annually (Annual APDU) to report project status and/or post implementation cost-savings, or, on an as-needed (As-Needed APDU) basis, to request funding approval for project continuation when significant project changes are anticipated; for incremental funding authority and project continuation when approval is being granted by phase; or to provide detailed information on project and/or budget activities as specified in § 95.610(c).
Advisory Board (AB)	Is a body that provides non-binding strategic advice to the management of a corporation, organization, or foundation.
Affordance (in system design)	The Appearance of the control should suggest to a user its functionality.

Age or Developmentally Appropriate	Is defined as activities or items that are generally accepted as
	suitable for children of the same chronological age or level of maturity or that are determined to be developmentally appropriate for a child based on the development of cognitive, emotional, physical and behavioral capacities that are typical for an age or age group. Agency File (NCANDS)	Contains data that are not reportable at the child-specific level and often gathered from agencies external to DFCS.
Agile Software Development	An umbrella term for iterative, incremental software development methodologies including Extreme Programming (XP), Scrum, Kanban, Crystal, Dynamic Systems Development Method (DSDM), Lean, and Feature-Driven Development (FDD). Agile development is an alternative to traditional phase-driven "Waterfall" development method, which emphasizes top-down project management, "big design up front," silos for architecture and design, coding, and testing, and extensive documentation. Agile methodologies share an emphasis on small teams delivering small increments of working software with great frequency while working in close collaboration with the customer and adapting to changing requirements.
Agile Sprint Planning	The process by which increments of work are planned, estimated, and committed to by the Contractor.
Alert	System reminder of an overdue Tickler.
Allegation Type	A claim against someone that sparks an investigation, such as abuse or neglect.
American Public Human Services Association (APHSA)	Nonprofit organization developing and promoting policies for the elderly and the economically disadvantaged.
Americans with Disabilities Act (ADA)	The Americans with Disabilities Act of 1990 (ADA) prohibits discrimination and ensures equal opportunity for persons with disabilities in employment, State and local government services, public accommodations, commercial facilities, and transportation. It also mandates the establishment of TDD/telephone relay services.
Annual Progress and Services Report (APSR)	Provide updates on a State's annual progress for the past fiscal year and planned activities for the upcoming fiscal year to satisfy federal regulations.
Anomalies	Unexpected events
Another Permanent Plan Living Arrangement (APPLA)	Also known as another planned permanent living arrangement (APPLA), a term created by the Adoption and Safe Families Act of 1997 to replace the term "long-term foster care." With OPPLA, the child welfare agency maintains care and custody of the youth and arranges a living situation in which the youth is expected to remain until adulthood. OPPLA or APPLA is a permanency option only when other options, such as

	reunification, relative placement, adoption, or legal guardianship, have been ruled out.
Application Program Interface (API)	A software intermediary that makes it possible for application programs to interact with each other and share data. An API is often an implementation of REST that exposes a specific software functionality while protecting the rest of the application.
Archiving Records	An accumulation of historical records or the physical place they are located
Area Social Work Supervisor (ASWS)	The employee within DFCS who monitors the initiation and completion of remedial actions regarding individual child safety and case practice. This person is also responsible for personnel action and supervision of assigned county social workers and their workload.
Assessing	The use of historical and current information about the family and the child to determine if the child is safe in their currently living environment. When assessing safety and risk a child welfare worker identifies risk factors and/or appropriate services to improve the family's situation.
Assessment	A written document which contains information relevant to the case situation and an appraisal of case service needs. California Manual of Policies and Procedures Division 31-002(a)(10).
Association of Administrators of Interstate Compact on Placement of Children (AAICPC)	The Association of Administrators of the Interstate Compact on the Placement of Children (AAICPC) was established in 1974 and consists of members from all 50 states, the District of Columbia and the U.S. Virgin Islands. The AAICPC has authority under ICPC to "promulgate rules and regulations to carry out more effectively the terms and provisions of this compact."
Association of Administrators of the Interstate Compact on Adoption and Medical Assistance (AAICAMA)	AAICAMA is a nonprofit organization comprised of member states working with child welfare agencies, tribes, and adoptive parents to facilitate and support special needs adoption. The association provides educational and technical assistance to enhance states' capacity to achieve timely permanency and needed services for adoption assistance-eligible children.
Asynchronous JavaScript and XML (AJAX)	A method of building interactive applications for the Web that process user requests without reloading the page.
Atlantic Coast Child Welfare Implementation Center (ACCWIC)	Regional Implementation Centers that works with States and Tribes on both specific problems and broad child welfare performance issues. The ACCWIC serves Delaware, the District of Columbia, Maryland, Pennsylvania, Virginia, West Virginia, Alabama, Florida, Georgia, Kentucky, Mississippi, North Carolina, South Carolina, and Tennessee. Federally recognized Tribes under this project include the Eastern Band of Cherokee Indians in North Carolina, Miccosukee Tribe of Indians in Florida, Mississippi Band of Choctaw Indians, Poarch Band of

	Creek Indians in Alabama, Seminole Tribe in Florida, and the Catawba Indian Nation in South Carolina.
Attorney General (AG)	Enforce both state and federal laws. Because they are sworn to uphold the United States' constitution and laws as well as the state's, they often decline to defend the state in federal lawsuits.

Chafee Foster Care Independence Program (CFCIP)	The John H. Chafee Foster Care Independence Program (CFCIP) offers assistance to help current and former foster care youths achieve self-sufficiency. The program is intended to serve youth who are likely to remain in foster care until age 18, youth who, after attaining 16 years of age, have left foster care for kinship guardianship or adoption, and young adults ages 18-21 who have "aged out" of the foster care system.
Change Control Board (CCB)	In software development, a Change Control Board (CCB) or Software Change Control Board (SCCB) is a committee that makes decisions regarding whether or not proposed changes to a software project should be implemented.

Child Abuse Prevention and Treatment Act of 1974 (CAPTA)	The Child Abuse Prevention and Treatment Act (Public Law 93- 247) provides federal funding to States in support of prevention, assessment, investigation, prosecution, and treatment activities and also provides grants to public agencies and nonprofit organizations for demonstration programs and projects. Additionally, CAPTA identifies the Federal role in supporting research, evaluation, technical assistance, and data collection activities; establishes the Office on Child Abuse and Neglect; and mandates the National Clearinghouse on Child Abuse and Neglect Information. CAPTA also sets forth a minimum definition of child abuse and neglect.
Child and Family Services Plan (CFSP)	(Five Year Strategic Plan) The CFSP is a strategic plan that sets forth a state's or tribe's vision and goals to strengthen its child welfare system. It outlines initiatives and activities that the state or tribe will carry out over the next 5 years to administer

	and integrate programs and services to promote the safety, permanency, and well-being of children and families.
Child and Family Services Review	The Child and Family Services Reviews (CFSRs) enable the Children's Bureau to ensure conformity with Federal child welfare requirements, to gauge the experiences of children, youth, and families receiving State child welfare services, and to assist States as they enhance their capacity to help families achieve positive outcomes.
Child and Family Services Review (CFSR)	The Children's Bureau conducts the CFSRs, which are periodic reviews of state child welfare systems. After a CFSR is completed, states develop a Program Improvement Plan (PIP) to address areas in their child welfare services that need improvement.
Child Awaiting Adoption (CAW)	a legally freed child that has been posted on a photo listing web site in an effort to identify an appropriate adoptive family by allowing other Adoption staff throughout the state to view information to help match a family to the child's need and desires.
Child Care Development Fund (CCDF)	CCDF is authorized by the Child Care and Development Block Grant Act and Section 418 of the Social Security Act. CCDF assists low-income families in obtaining childcare so they can work or attend training/education. The program also improves the quality of childcare and promotes coordination among early childhood development and afterschool programs.
Child File (NCANDS)	Contains case-level data. States submit case-level data by constructing an electronic file of child-specific records for each report of alleged child abuse and neglect that received a CPS response.
Child in Need of Supervision (CHINS)	A child who has reached his seventh birthday and is in need of treatment or rehabilitation because the child:(i) Is habitually disobedient of reasonable and lawful commands of his parent, guardian or custodian and is ungovernable; or(ii) While being required to attend school, willfully and habitually violates the rules thereof or willfully and habitually absents himself therefrom; or(iii) Runs away from home without good cause; or(iv) Has committed a delinquent act or acts. Child Protective Services (CPS)	the name of a governmental agency in many states of the United States that responds to reports of child abuse or neglect.

A Path 1, Differential Response is chosen when allegations do not meet statutory definitions of abuse or neglect, and the family is given an opportunity to embrace community services. A Path 2 Differential Response is chosen when reports meet statutory definitions of abuse or neglect, and assessments indicate that with targeted services a family is likely to make needed improvements to improve child safety.

Performance Improvement Plan (PIP)	The plan that States are required to submit to the Federal Government if found out of conformity on any of the seven outcomes or seven systemic factors subject to review in the Federal Child and Family Services Reviews.
Performance Standards	The standards relating to the operation of an individual Module and/or the System as a whole as described in the Contract.
Periodic Administrative Review (PAD)	Review instrument for the Foster Care Review Unit that is automated in MACWIS which allows findings from the review to be stored directly in the electronic case file and enhances the county's and region's ability to follow up on case review findings. Reviewer are able to document the comments made during the county conference and to assist in making findings on the mandated determinations of compliance with case planning, conduciveness/appropriateness/ restrictiveness of the child's placement, progress toward alleviating the causes that led to custody, and continuing need for custody as well as appropriateness of the child's permanent plan.

Permanency Roundtable	Permanency Roundtables (PRT) are internal agency staffed meetings held to determine if permanency can be accelerated for children/sibling groups in foster care for more than three years.
Perpetrator	A person who is believed to commit an act of child abuse.
Person Identifier (PID)	A subset of personally identifiable information (PII) data elements that identify a unique individual and can permit another person to "assume" that individual's identity without their knowledge or consent.

Person-data relationship	Identifies the person and relationship to data in an intake, investigation or case.
Physical Removal	the physical act of a child being taken from his or her normal place of residence, by court order or a voluntary placement agreement and placed in a substitute care setting. ACYF-CB- PIQ-94-01
Place Pay	Place Pay record - a record created from the placement resource, dates of placement and board rate for child.
Placement	Physical location/address of a foster child
Placement Resource	An entity where a child may be placed for foster care or adoption.
Planning Advanced Planning Document (PAPD)	Describes in high level terms the desired integrated application environment planned.
Primary Vendor	In a Hierarchal relationship of vendors, the higher level or managing vendor.
Private Agency	A non-family entity providing placement services, including Umbrella Agencies and Facilities. This could include publicly owned facilities.
Product (or Program Product)	The packaged collection of software created pursuant to this Contract in order to fulfill the scope of work.
Product Backlog	A prioritized and estimated list of all outstanding product/project requirements, features, defects and other work items.
Product Owner	An empowered individual who will interface with the client's stakeholders, synthesize feedback, and make decisions on the product's priorities and scope.
Product Roadmap	The high-level initiatives and the planned steps that communicate direction and progress to internal teams and external stakeholders.

Referral to community agency	When the determination that a child abuse investigation is not warranted but other needs are identified, the referral may be sent to a community agency for follow-up.
Referrals	Emergency response Referrals contain information in regard to allegations of child abuse, neglect, or exploitation as defined by Penal Code Section 11165 et seq., Welfare and Institutions Code, and the Division 31 regulations. Emergency response referrals do not include inappropriate inquiries such as those regarding aid payments, etc.

Supervisor Administrative Review (SAR)	A mandatory review completed by the COR Supervisor of all cases within 90 days after opening such cases, regardless of the service type to meet the requirements of MISS. CODE ANN. § 43-15-13(3).
Supplemental Security Income (SSI)	A United States government program that provides stipends to low-income people who are either aged (65 or older), blind, or disabled. Although administered by the Social Security Administration, SSI is funded from the U.S. Treasury general funds, not the Social Security trust fund.
