ordered and shipped to Recipient Agencies. However, if the MDE choose to process in the future it is expected that the solution would meet all the USDA reporting requirements as well as inventory requirements including

reconciliation.

Question 4: Att. A, III.A.153, page 13 - Can you please confirm what USDA programs other than NSLP are desired for the Food Distribution Software?

Response: Summer Feeding and DOD Fresh Fruits & Vegetables are additional programs desired for the Food Distribution Software. The solution should be able to add programs such as BONUS and CCC (Commodity Credit Corporation), being used currently for Supply Chain Assistance, or any other added federal grant programs which will offer entitlement and USDA Foods to the State for distribution to Recipient Agencies.
