- Response: With the exception to anything listed as MANDATORY, any item in the RFP documents that a Vendor disagrees with or wishes to negotiate must be included in their response to the Proposal Exception Summary Form listed in the RFP in Section V.
- Question 3: RFP, Section IV: Legal and Contractual Information, Item 7.2: Section 7.3 invites the Vendor to propose a limitation of liability. Except for claims related to infringement, bodily injury, death, physical damage, and intentional misconduct, will the State accept a mutual liability cap of up to the total contract value?

With the state accept deletion of warranty that the deliverables are free from defect, it is vague as to whether data is "defective?"

Question 6: RFP, Exhibit A: Standard Contract, Article 13: Will the State accept a carveout from the consent requirements for assignment where the Agreement is assigned to Vendor's affiliate, to the surviving entity in a merger or consolidation or to a purchaser of all or substantially all of its assets or equity?
